- How does your marau ā kura reflect hapū/iwi/mana whenua/community?
- Can your kaiako and kura leaders explain with confidence your marau ā-kura?
- Can your mokopuna explain your marau ā-kura?
- Do you feel your kura communities have ownership of your marau ā kura? How do you know?
- How do you plan to implement your marau ā kura?
- Are there stages in the implementation of your marau ā kura? What are they?
- How will you measure the success of the implementation of your marau ā kura?
- How will you report the success or otherwise of implementation to your communities?
- What information will be collected in the measuring phase of implementation?
- What is your inquiry question?

Mātau/Ora:

- How does your marau ā kura reflect hapū/iwi/mana whenua/community?
- Can your kaiako, kura leaders and mokopuna explain with confidence your marau ā-kura?
- Do you feel your kura communities have ownership of your marau ā kura? Explain
- How do you plan to review your marau ā kura?
- Are there stages in the review of your marau ā kura? What are they?
- How will you measure the success or otherwise of the implementation of your marau ā kura?
- How will you report the success or otherwise of the implementation to your communities?
- What information will be collected in the measuring phase of the review?
- What is the best way to get feedback on the marau ā kura?
- Is your marau ā kura embedded in kura documentation?
- How do you measure mokopuna progress in relation to marau ā kura outcomes?
- Is your marau ā-kura explicit in teaching and learning plans and units of work?
- Are there specific goals in your strategic plan/charter that reflect outcomes of your marau ā kura? What are these?
